Xiaosong, thanks for the clarification. I am trying to draft the letter to include the additional information you have requested. Please help me verify the following:

1. We will give you an authorization to use the SAIC manual and the drawings. I will include that with our response letter
2. We will have Exploranium define a more secure mounting method for the 820, and explain what that method will involve. I will either attach a written description and/or a new drawing
3. The preference is to be able to use either the license number or the SAIC name on the labels. Can I say either? If we do use the license number, and I need to reference this on the label, do I just say Exempt Distribution License XXXXX, or can you tell me what the number will be ahead of time so I can include it.

Linda,

To your QA/QC on Exploranium's products, 5% LTPD sampling rate is acceptable to NRC.

There are some other issues we need your response:

1. The drawings provided are marked no unauthorized use or reproduction and some from Exploranium are also marked proprietary. We need a release from you to use them for the license. We also need a release from you, for our licensing purpose, that the statement you made on your Personal Dosimeter Reader models PDR-1 and PDR-1/S, manual is marked on page 1 that unauthorized reproduction prohibited.
2. The application, Attachment 3: List of Instruments with Installed Check Sources....., states that source 98005 is secured by tape in Drawing No. 98300 for the GPX-1024/256, Exploranium Radiation Detection System. This does not meet 10 CFR32.14(a)(3) and (4) expectations.
3. Labels should indicate the name of the US exempt distribution licensee applicant name (SAIC) rather than Exploranium as indicated on the drawings. An alternative would be to use the exempt distribution license number instead of the name pursuant to 32.14(b)(6) & 32.18(d).

When we receive your responses, we will continue our expedited review of the application.

Xiasong, thank you for the feed back. I am afraid I need a little bit of help interpreting the requirements for item 1 below. I have carefully read the regulatory guide 6.9 and the requirements in 32.15 and 110. The regulatory guide refers to an attachment C for the modified sampling frequency and LDT for certain products. However, when you go to attachment C it appears to only apply to foil sources in smoke detectors or gas ionization type of exempted articles. Since the units we are discussing for the SAIC application don't fall into any of these categories, we assumed our program should default back to the 5% LDT in the 32.110 sample criteria? Is that correct? If so, I will define both in email and in a follow up letter that we will conform to that sampling protocol and LTD. It is also my understanding that the LTDs listed in 32.110 only apply to those sources physically installed in devices. For the loose sources that we will redistribute, those inspections are not required. If this is incorrect, and you want us to use the foil source/smoke detector LDT then please let me know . I will also confirm in writing that both SAIC San Diego and SAIC Canada are controlled by the same entity (SAIC). Thank you so much for all the help to date.
