

I live in [REDACTED], a beautiful community of 20,000 people situated on the [REDACTED]. My children and grandchildren live in the area as well.



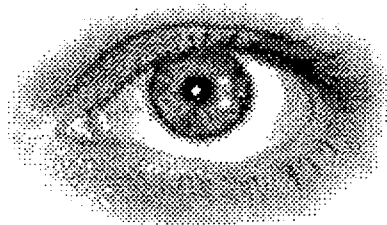
Please take the time to consider the irreversible damage to our population, environment and my future if the Davis-Besse nuclear power plant's problems are allowed to continue without accountability.

Besides all of the health issues and dangers to those living near David-Besse I see one issue that would directly affect me is the loss of our Lake Erie.

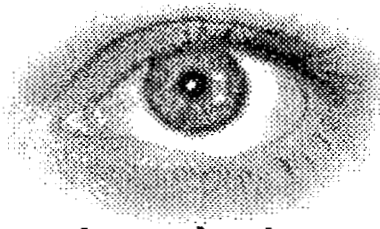

First off, let me state that I am a firm believer in nuclear power. I think that it is currently the most efficient way to provide mass power without mass pollution.

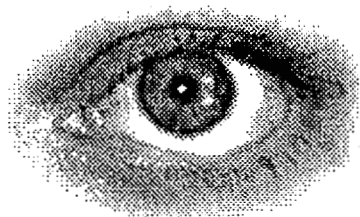
