Due to administrative oversight, the transmittal cover letter that submitted TQP, Revision 8-6 identified the enclosure (see attached) as containing Safeguards information.

This submittal is being provided to inform the NRC that due to a transposition error with another Security document that was being submitted at the same time as the TQP, the reference to Safeguards information was incorrect.
