SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE  
FOR NOVEMBER 14, 2003, RESPONSE TO REQUEST FOR ADDITIONAL  
INFORMATION (RAI) (MFN-03-144)

Dear Dr. Rao:

By letter dated November 14, 2003, from Sandra A. Delvin and associated affidavit executed on November 14, 2003, by George B. Stramback, you indicated that information contained in the response to Request for Additional Information (RAI) number 406 for the ESBWR pre-application review should be withheld as proprietary. You requested that this information be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations*, Section 2.790 (10 CFR 2.790).

The submitted CD contains TRACG computer code output and graphic files, and you indicated that a non-proprietary version of these files is not available.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (1) the information discloses a process, method, or apparatus including supporting data and analyses, where prevention of its use by General Electric Company's competitors without license from General Electric constitutes a competitive economic advantage over other companies; and
- (2) the information, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your letter and affidavit in accordance with the requirements of 10 CFR 2.790 and, on the basis of your statements, have determined that the information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
