In a letter dated December 10, 2003, the U.S. Army (the licensee) submitted a license amendment request for the Jefferson Proving Ground (JPG) site. The Army's license amendment request is to change the certifying official from Dr. John M. Ferriter to Colonel Mike G. Mullins, Office of the Commander, Department of the Army, 1 Rock Island Arsenal, Rock Island, IL. A signed NRC Form 313 and a revised JPG Security Plan were submitted along with the letter (See Attached). This is similar to the change in command that resulted in License Amendment No. 10.

In a letter dated December 31, 2003, NRC staff determined that it is acceptable to transfer licensing responsibility for the JPG site to Rock Island Arsenal because the level of U.S. Army management involvement remains the same.
