Representatives from NMC made a presentation and provided the NRC staff with slides (Enclosure 2). The NMC staff discussed their technical justification for potential repairs that may overlap remnant J-groove welds on the upper reactor vessel head penetrations at Point Beach.

Some of the issues discussed were as follows:

- Contingency repair plans for the Point Beach Nuclear Plant Unit 2 refueling outage in October 2003.
- The design challenges associated with the Point Beach Nuclear Plant Westinghouse 2-loop design. This is the only 2-loop currently in operation.
- Reactor pressure vessel head replacement planned for spring 2005.
