SUBJECT: SUMMARY OF THE NOVEMBER 12, 2003, PUBLIC MEETINGS TO DISCUSS  
THE MANUAL CHAPTER 0350 PROCESS AT DAVIS-BESSE

On November 12, 2003, the Nuclear Regulatory Commission (NRC) held two public meetings at the Oak Harbor High School in Oak Harbor, Ohio. The first meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss licensee performance and progress on the Return to Service Plan as part of the IMC 0350 Process.
