

- Intergovernmental Resource Center

The IRC will support DOE/HQ activities:

- Planning and policy
- Negotiations, meetings, briefings and hearings
- Review of technical and institutional documents

The IRC will contain:

- State, Indian Tribal and local government documents
- General background information
- Institutional plans and guidelines

DOE asked States and Indian Tribes for:

- Assistance in developing a list of documents
- Suggestions of State and local newspapers
- An appropriate approach for obtaining local governments' input

More documents are needed:

- Yakima Indian Nation, Confederated Tribes of the Umatilla Indian Reservation, and Nez Perce Indian Tribe laws, budgets, and plans
- Local government documents, especially Washington and Texas

Next Steps:

- Expand preliminary list using documents recommended by States, Indian Tribes and local Governments
- Collect intergovernmental documents
- Draft a briefing book to be available for review by States and Indian Tribes
- Finalize briefing book and document index and make available on Infolink

- Action Item 7a: DOE will examine the potential relationship between the IAC and the Licensing Support System (LSS) .
- DOE Response: The IAC will be incorporated into the LSS and the IMS.

- Action Item 7b: DOE will consider the appropriateness of including non-government organizations in the IRC.
- DOE Response: The IRC will not contain non-governmental documents.

- Action Item 7c: OGR will discuss with OSTs the relationship between the IRC and the inclusion of information pertaining to corridor States.
- DOE Response: The IRC will contain information only on the repository States, Indian Tribes and local governments.

- Action Item 7d: DOE will examine the relationship, if any, between the IRC and the issue tracking system.
- DOE Response: The IRC and the issue tracking system have no direct relationship.

- Action Item 7e: DOE will consider including in the IRC information on federal laws and regulations from agencies other than DOE.
- DOE Response: The LSS and IMS, rather than the IRC, will contain information on federal laws and regulations from other agencies.

- Risk Assessment

RISK

- **A hazard or chance of loss; usually includes both the loss and the probability associated with the loss**

RISK ASSESSMENT

- **Probabilistic Risk Assessment (PRA)**

- **deals with the impacts of a hypothetical event weighted by the probability that it will occur**
- **provides an expected damage estimate due to the constructed event**
- **deals with actual physical damage resulting from an accident**
 - **(e.g., to buildings, environment, economic activity)**

PERCEIVED RISK

- **Perception that a hazard or chance of loss exists due to an event**
- **No actual physical damage is necessary nor is there a need for an accident to ever occur for there to be a degree of perceived risk**

PERCEIVED RISK

- **Economic impacts due to perceived risk**
 - **the perceptions that a hazard or chance of loss exists due to an event may result in a change in the economic behavior of individuals affecting local trade, property values, tourism and/or industrial activity**

PERCEIVED RISK

- **Economic impacts due to perceived risk**
 - **in this area, it is appropriate for DOE to:**
 - **communicate effectively to the public what our project is, how we will conduct our project**
 - **provide grant money to states and Indian tribes to provide information to its residents regarding DOE activities**

PERCEIVED RISK

- In this area, it is also appropriate for DOE to:
 - understand the concerns of states and Indian tribes
(Section 117 of NWPA - consultation and cooperation)
 - define terms, data and concerns
 - review the literature and existing research done in this area

ELIGIBLE JURISDICTIONS

CLARIFICATION OF DOE WORKING DEFINITION OF SITE (SECTION 4.1, PGS. 6-7)

- **THE DOE WORKING DEFINITION OF SITE IS BASED ON THE AREA OF LAND THAT, IF SELECTED AS A REPOSITORY, COULD EVENTUALLY BE CONTROLLED BY DOE PURSUANT TO THE REQUIREMENTS OF THE NUCLEAR REGULATORY COMMISSION.**
- **THE SITE IS IDENTIFIED AS THAT AREA OF LAND ENCOMPASSED BY A CIRCUMFERENCE THAT IS FIVE (5) KILOMETERS FROM THE NEAREST POINT ON THE PLANNED UNDERGROUND FACILITY:**
 - **THIS AREA IS LARGER THAN THE ACTUAL NRC REQUIREMENTS FOR THE "CONTROLLED AREA", WHICH WILL NOT EXCEED 100 SQUARE KILOMETERS; AND**
 - **THERE MAY BE AN EVENTUAL NEED FOR DOE TO CONTROL LANDS OUTSIDE OF THE CONTROLLED AREA.**

ELIGIBLE JURISDICTIONS

CLARIFICATION OF APPLICABLE TAXES: BASIS FOR ELIGIBLE PROPERTY AND ACTIVITIES (SECTION 4.3, PG. 7)

THE LIABILITY FOR PETT DOES NOT EXIST UNTIL DOE CONDUCTS ACTIVITIES AT THE SITE FOR WHICH THE STATE AND UNITS OF GENERAL LOCAL GOVERNMENT, WITHIN THE BOUNDARIES OF THE SITE, WOULD OTHERWISE IMPOSE APPLICABLE TAXES ON COMPARABLE PROPERTY AND INDUSTRIAL ACTIVITIES AT THE SITE. - **HEADQUARTERS MUST CONCUR ON ALL AGREEMENTS REACHED BETWEEN ELIGIBLE JURISDICTIONS AND THE PROJECT OFFICES. THE OFFICE OF GEOLOGIC REPOSITORIES (OGR) WILL COORDINATE THE HEADQUARTERS CONCURRENCE PROCESS.**
- **HEADQUARTERS IN CONSULTATION WITH PROJECT OFFICES, WILL BE RESPONSIBLE FOR PERFORMING PROGRAMMATIC, FINANCIAL AND LEGAL REVIEW OF PETT AGREEMENTS.**

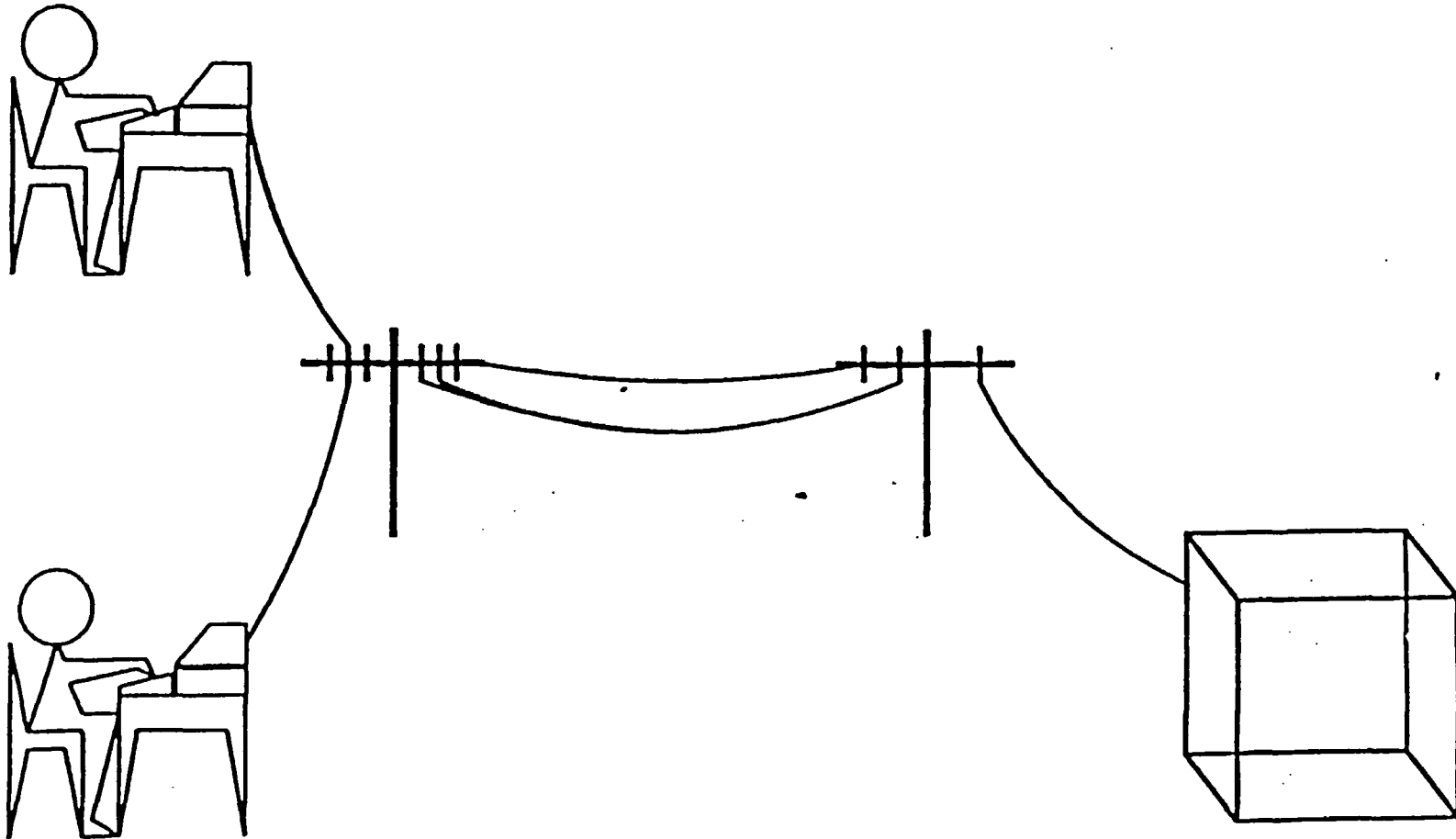

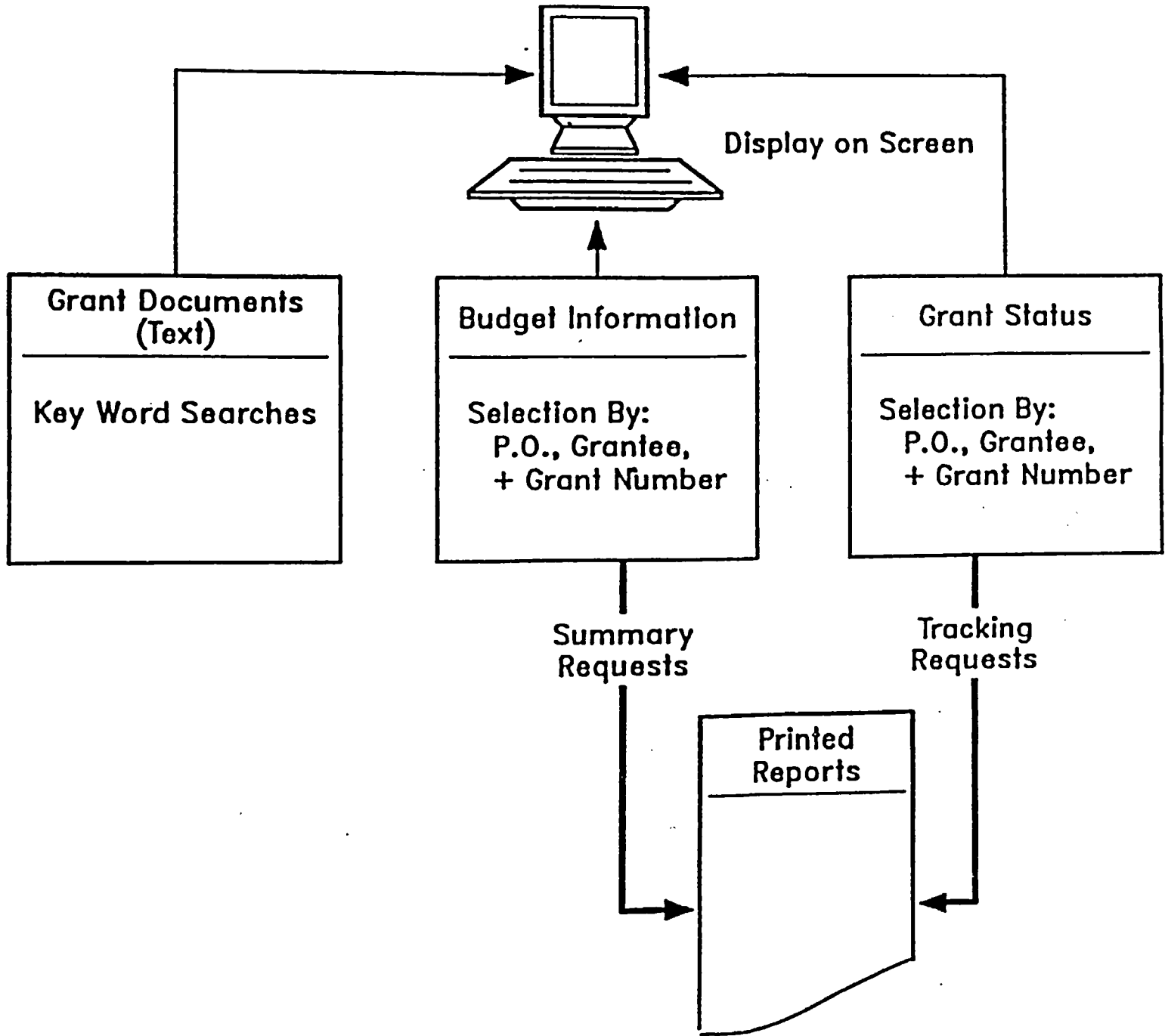
