The purpose of this modification is to provide incremental funding in the amount of \$250,000 hereby increase the obligated amount from \$1,080,000 to \$1,330,000. Accordingly, the contract is hereby modified as follows:

Under Section B.3, Consideration and Obligation—Cost Plus Fixed Fee (JUN 1988) ALTERNATE I (JUN 1991), paragraphs (i) and (j) are deleted in their entirety and following is substituted in lieu thereof:

- “(i) The amount currently obligated by the Government with respect to this contract is \$1,330,000 of which the sum of \$1,231,473 represents the estimated reimbursable costs and the sum of \$98,527 represents the fixed fee.
- “(j) It is estimated that the total obligated amount will cover performance through July 30, 2004.”

All other terms and conditions of the contract remain unchanged.

This modification obligates FY 04 funds in the amount of \$250,000.
