By Pacific Gas and Electric Company (PG&E) Letter HIL-03-001, dated December 15, 2003, PG&E submitted an application to the Nuclear Regulatory Commission (NRC) requesting a site-specific license for an Independent Spent Fuel Storage Installation (ISFSI) at the Humboldt Bay Power Plant. The application included a Safety Analysis Report, Environmental Report, and other required documents in accordance with 10 CFR 72.

PG&E is submitting Enclosure 1, which contains the proposed Humboldt Bay ISFSI Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan for NRC approval.



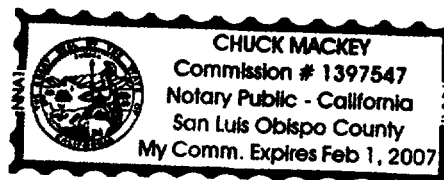
