NUCLEAR REGULATORY COMMISSION (NRC) - COMMENTS ON IMPLEMENTATION OF
A PILOT PROGRAM ON THE USE OF ALTERNATIVE DISPUTE RESOLUTION (ADR)
IN THE ENFORCEMENT PROGRAM (68 FEDERAL REGISTER 67492, DATED
DECEMBER 2, 2003)

TVA appreciates the opportunity to submit comments for NRC's
consideration as it develops an ADR pilot program for use in cases
involving discrimination or other wrongdoing. TVA also supports
the comments made by the Nuclear Energy Institute by letter dated
December 19, 2003, regarding the pilot ADR program.

TVA has previously provided comments on the benefits of an ADR
pilot program at a public meeting held by NRC in New Orleans,
Louisiana, on October 10, 2002. TVA continues to believe that ADR
can minimize the time to obtain a resolution; be less adversarial
than the current processes; promote greater communication and, in
turn, greater cooperation among the parties; minimize the need for
a large commitment of staff and resources; and lead to timelier and
better corrective action if such action is warranted. TVA also
believes that ADR does not affect NRC's ongoing obligation to
ensure that the underlying safety issue has been or will be
addressed. Agency review of the agreed upon resolution will also
ensure that it does not contain terms that would violate NRC
requirements.
