The Nuclear Regulatory Commission (NRC) does not review and approve courses such as you have described. It is the preceptor authorized user's responsibility to determine if the individual has satisfactorily completed the training and experience requirements in the regulations and has achieved a level of competency to function independently as an authorized user. It is the licensee's responsibility to approve in writing any individual before that individual can work as an authorized user. Whether your proposed instruction is sufficient to meet the classroom and laboratory training needs for an individual seeking authorized user status will be determined by that individual's existing knowledge and ability to achieve a level of competency to function independently. NRC will review all documentation from an NRC licensee to determine if the individual can be listed as an authorized user on the NRC license.
