
SUBJECT: Report of Full Compliance with All of the Compensatory Measures of the Order for Compensatory Measures Related to Access Authorization

References 3, 4, and 5 detailed Omaha Public Power District's (OPPD) responses to the requirements of Reference 2 for Fort Calhoun Station Unit No. 1 (FCS). Reference 2 requires that implementation of the compensatory measures (CM) shall be completed no later than July 7, 2003 with the exception of CM B.1.1 which shall be completed no later than April 7, 2003, and CM C.1.6 and CM C.1.8, which shall be completed no later than January 7, 2004. Reference 2

also states that Licensees shall report when they have achieved full compliance with the requirements of Reference 2. Reference 6 stated that OPPD had achieved full compliance with CM B.1.1. Reference 7 stated that OPPD had achieved full compliance with the requirements of Reference 2 at FCS, with the exception of CM C.1.6 and CM C.1.8 which were to be completed by January 7, 2004 per Reference 3. As of January 7, 2004, OPPD has achieved full compliance with all of the requirements of Reference 2, including CM C.1.6 and CM C.1.8.
