As I have indicated earlier to Ms. Curran, Duke Energy objects to the request for an extension of time. In addition, Duke Energy does not believe that there is a need for additional security information in order to draft security contentions in this proceeding, and in that respect concurs with the NRC Staff.

Duke Energy is very interested in resolving this motion promptly.
