**ORDER REDUCING AND ALLOWING CLAIM OF  
SEMPRA ENERGY SOLUTIONS (CLAIM NO. 775)**

Fansteel Inc. ("Fansteel") and its affiliated debtors and debtors-in-possession (collectively, the "Debtors") having advised Sempra Energy Solutions ("Sempra"), a creditor herein, that the Debtors intended to interpose a formal objection to the allowance of the proof of claim filed by Sempra in the amount of \$467,262.48 (Claim No. 775) in Fansteel's Chapter 11 case; and it appearing that Sempra has agreed in writing to reduction of its claim as reflected by the copy of the letter agreement annexed hereto as Exhibit "A"; and notice of presentment of this Order having been given, it is hereby

**ORDERED**, that Claim No. 775 filed in the Chapter 11 case of Fansteel in the amount of \$467,262.48 is hereby reduced to the sum of \$26,000.00 and is allowed as a Class FAN-3 general unsecured claim in such reduced amount pursuant to the confirmed plan of reorganization for the Debtors.
