The meeting was between the NRC Davis-Besse Oversight Panel, Restart Readiness Assessment Inspection Team, Management and Human Performance Inspection Team, and FirstEnergy Nuclear Operating Company (FENOC) to discuss the results of the Restart Readiness Assessment Team Inspection and the Management and Human Performance Team Inspection.
