Dear Mr. Linehan:

The Department of Energy would like to schedule a technical exchange with the Nuclear Regulatory Commission (NRC) on September 29 and 30, 1988, covering the waste acceptance process (WAP) with respect to defense waste. The WAP was developed to formalize the activities within the Office of Civilian Radioactive Waste Management (OCRWM) to ensure waste form acceptability at the repository site.

One of OCRWM's responsibilities in coordinating waste form activities is to schedule technical exchanges with the NRC. Presently, the Defense Waste Processing Facility (DWPF) construction is nearing completion. Technical information concerning waste acceptance at this facility is ready for discussion with NRC. Enclosed please find a draft agenda (Enclosure 1) for the proposed technical exchange. If you have any comments or questions on the agenda items, we ask that you contact us in advance of the meeting.

We plan to interact with NRC at appropriate points as we move through the waste acceptance process and update the status of DWPF construction and startup activities.
