DOE-RL QUALITY AUDIT 8703 BASALT WASTE ISOLATION DIVISION (BWI) ACTIVITIES

A Quality Assurance Audit of DOE-RL BWI activities is planned for April 14-16, 1987. The scope of the audit is provided in Enclosure A and will address QA Program elements as applicable to the specific organizations within BWI. Since the Document Control Center (DCC) is an integral part of many of the BWI activities, it will also be briefly audited for NOA-1 Criterion VI, Document Control, even though the organization reports to the Rockwell Hanford Operation.

The entrance meeting is scheduled for 9:00 a.m., April 14, 1987, in Conference Room 434 of the Federal Building. The exit meeting is tentatively planned for 1:30 p.m., April 16, 1987, in the same Conference Room. The audit team leader, Mr. W. B. Williams, will be in contact with each Branch Chief and the supervision of the DCC to establish specific schedules and availability of personnel who will be involved in the audit. Enclosure B is a tentative schedule for the audit.
