SITE CHARACTERIZATION PLAN - CHAPTER 4

Enclosed for your information is a draft copy of Chapter 4 of the Basalt Waste Isolation Project (BWIP) Site Characterization Plan (SCP) which is being prepared by the Department of Energy (DOE) pursuant to the Nuclear Waste Policy Act. This version of Chapter 4 is being released specifically to provide you with an early opportunity to become familiar with the content and level of detail prior to formal release of the final SCP for public comment. In this regard, the DOE is not soliciting comments on the subject site characterization section.

At this time, the DOE is still preparing and integrating the individual chapters and reviewing the assembled document for consistency. A tentative release schedule for other draft chapters/sections is included. While the technical material contained in this working document is similar to the expected final SCP, the contents of this section should not be construed to necessarily represent a final DOE position with respect to any particular issue.
