The ACRS Subcommittee on Waste Management will hold a meeting on May 18 and 19, 1987, Room 1046, 1717 H Street, NW, Washington, DC.

The entire meeting will be open to public attendance.

The agenda for the subject meeting shall be as follows:

Monday, May 18, 1987 - 8:30 A.M. until the conclusion of business

Tuesday, May 19, 1987 - 8:00 A.M. until 12:00 Noon

The Subcommittee will review the following topics: A. High-Level Waste:

(1) Impact of NMSS reorganization on waste management program, (2) Overview of QA program and activities, (3) Waste acceptance activities regarding the processing of radioactive wastes into glass, (4) Update on the National Bureau of Standards' waste form program, (5) Generic Technical Position (GTP) on Qualification of Existing Data for HLW Repositories, (6) GTP on Peer Review for HLW Repositories, and (7) Report on the Hanford, Washington (BWIP) hydrology meeting. B. Waste Management Research: (1) Demonstration of Performance Modeling of a LLW Shallow Land Burial Site -- the nitrate disposal pit site at Chalk River, Canada, and (2) Control of Water Filtration into Near Surface LLW Disposal Units. C. Low-Level Waste: (1) Update on status of mixed wastes issue, and (2) Greater than Class C wastes.


Oral statements may be presented by members of the public with the concurrence of the Subcommittee Chairman; written statements will be accepted and made available to the Committee. Recordings will be permitted only during those portions of the meeting when a transcript is being kept, and questions may be asked only by members of the Subcommittee, its consultants,

and Staff. Persons desiring to make oral statements should notify the ACRS staff member named below as far in advance as is practicable so that appropriate arrangements can be made.

During the initial portion of the meeting, the Subcommittee may exchange preliminary views regarding matters to be considered during the balance of the meeting. The Subcommittee will then hear presentations by and hold discussions with representatives of the NRC Staff and other interested persons regarding this review.
