The NRC staff has performed an acceptance review of the TR. We have found that the material presented is sufficient to begin our comprehensive review. The staff does not expect to issue requests for additional information. The staff will complete its review by March 1, 2004, and estimates that the review will require approximately 20 staff hours including project management time. The review schedule milestones and estimated review costs were discussed and agreed upon in a telephone conference between Mr. Jerald Holm and the NRC staff on January 26, 2004.
