The purpose of this modification is to provide incremental funding in the amount of \$50,761.00, thereby, increasing the obligated amount from \$265,018.00 to \$315,779.00. Accordingly, the contract is modified as follows:

Under Section C.3, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUNE 1988) the first sentence of Paragraph (b) is deleted entirely and replaced with the following:

“c) The amount presently obligated with respect to this contract is \$315,779.00.

All other terms and conditions of this contract remain the same, including the contract ceiling amount of \$753,271.00.
