

The purpose of this modification is to 1) Exercise the option to extend the period of performance of the contract, from February 25, 2004 through February 24, 2005 and 2) Increase the ceiling amount in the contract by \$533,770.00 from \$507,072.00 to \$1,040,842.00. Accordingly, the contract is hereby modified:

1. Section B, Subsection B.2, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), paragraph (a), first sentence, is deleted and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$1,040,842.00."

2. Section B, Subsection B.4, PERIOD OF PERFORMANCE - CONTRACT, is deleted and substituted with the following in lieu thereof:

"The ordering period for this contract shall commence on February 25, 2003 and will expire on February 24, 2005. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. The term of this contract may be extended at the option of the Government for two additional one-year periods."

This modification obligates no funds. Funding will be provided on an individual delivery order basis.

All other terms and conditions of the subject contract remain unchanged.
