In several telephone conferences held between members of the NRC staff and licensee representatives we discussed a portion of STP Nuclear Operating Company's (STPNOC) initial response (Reference 1) to the Armed Security Officer Training Order. As discussed, this letter amends STPNOC's initial response by withdrawing Enclosure 3 of our initial response. Enclosure 3 provided clarification of training frequencies to allow necessary flexibility during implementation of the Order. NEI 03-09, Security Officer Training Program, which is being submitted to the NRC for endorsement, provides adequate guidance on training frequencies, therefore clarification by STPNOC is no longer necessary.
