#### SUMMARY

The key staff involved with the two contracts mentioned in the letter met to discuss the contents of the letter, and the sensitivity of the State of Texas to potential activities of the contractor.

The letter was examined line-by-line for misconceptions and inaccuracies regarding the activities in the Palo Duro Basin, and the Lawrence Berkeley Laboratory and Sandia Laboratories contracts. Areas noted were:

- 1) "select" = evaluate (more descriptive term)
- 2) "potential" = representative (more descriptive term)
- 3) "that site" = these kinds of sites (more descriptive term)
- 4) Field Work: "If another or any research team in the Palo Duro Basin gave an impression of "siting" at this time it would create a substantial impediment to the program". (Apparent sensativity to the May Texas Trip of geologists).
- 5) Contract misinformation needs to be clarified basically paperwork/modeling, some local literature searches possible.
- 6) DOE coordination NRC has a Procedural Agreement with DOE that covers activities, and contract work is reviewed by the Home Office for Laboratory work.
- 7) Contact with Ed Vetter's office no NRC or contractor contact was made, calls need to be made regarding both contracts and to clarify misinformation.

  NOTE: Only contact made was by Seth Coplan to Tom Gustofson, Texas Survey, 4 to 6 weeks ago, indicating there may be a need for some local literature.
