TECHNICAL INTERFACES WITH BWIP

To streamline the flow of technical information between BWIP (both DOE and RHO) and NRC, communicators have been designated for each main study topics, as shown on the attachment. As communication needs are identified for other topics, e.g. environmental matters, additional individuals will be nominated.
