STATUS OF HYDROLOGY ACTIVITIES AT THE BWIP SITE; PREPARATION

FOR THE UPCOMING HYDROLOGY MEETING

SUMMARY

I called Mr. Thompson to inquire about the status of hydrology activities at the Hanford site and about future NRC-DOE interactions about BWIP hydrology. Mr. Thompson indicated unofficially that DOE-RL would like meet with NRC to discuss hydrology testing strategies sometime between September 22 and October 3, 1986.

I responded favorably to this suggestion and promised to inform DOE-RL of dates that would be convenient for NRC to meet. I emphasized the importance of NRC receiving DOE's strategy in writing prior to the meeting to allow NRC to review the strategy and provide DOE with constructive comments during the meeting. He indicated that the strategy could probably be described in some written form in time for NRC to review it prior to the meeting. Mr. Thompson stated that the meeting would relate the hydrology testing strategy to other site activities and the issue resolution strategy.

I suggested that NRC and DOE consider piggybacking a data review with the meeting because NRC staff needs to review hydrologic testing data collected at Hanford since early 1984 prior to reviewing the SCP. He indicated that this suggestion sounded reasonable.
