Dear Mr. Olson:

Per discussion with you today, the purpose of this letter is to identify access needs for the BWIP On-Site Representative per item 7 of Appendix 7 of the DOE/NRC Procedural Agreement. Although we did not discuss areas other than the FPB Building and the NSTF, I have listed all the areas I consider pertinent to my activity.

In this regard I have a continuing need for ready access to review records and observe testing or other data-gathering activities. Such access, on a not-to-interfere basis, is in accordance with items 3 and 7 of Appendix 7 of the Procedural Agreement. (This letter is not intended to identify a need to contact any particular contractor or subcontractor personnel for a meeting or discussion as provided in items 1 and 2 of Appendix 7. Such requests for meetings or discussion sessions with personnel will be made separately on a case basis, and usually, informally, through verbal communication with cognizant personnel identified in item 2 of Appendix 7.) Contacts with personnel will be limited to logistics associated with safety, security and access to records kept at the specific location being visited, if prior arrangement for discussion or meeting is not made.

The areas and facilities are:

1. Near Surface Test Facility, including tunnels 1, 2, and 3, records and equipment storage areas and office spaces.
2. 200E area including RHO office spaces in 2750E and 2101M, Engineered Barriers Department laboratory and Engineering Management Systems library.
3. Dry Ecology Site area including McGee Well, Rattlesnake Mt./Snively Basin area, Umtanum Ridge and Yakima Ridge areas.
4. 200W area including Engineered Barrier Materials testing area in 222S and related office space and records storage areas.
5. 300 area including radiation testing in the 325 building

and related Westinghouse office spaces and records storage areas.

6. 3000 area including PNL laboratories accomplishing testing for BWIP or maintaining records for BWIP sponsored activities.
7. CDC buildings' office spaces and records storage areas.
8. FPB building office spaces and records storage areas.
9. 1135 Building office spaces including seismograph recording room and records storage areas.
10. Federal Building DOE office spaces and record storage areas.
11. Morrison-Knudsen Co., Inc. office spaces and records storage areas.
12. Raymond Kaiser Engineers Inc./Parsons Brinckerhoff Quade, & Douglass, Inc. Oakland office spaces and records storage areas.
13. All hydrologic test wells, including their enclosures, under BWIP cognizance.

My current security badge provides for my access to the general 200E and W, 300, 600 and 700 areas. Potentially additional badging is necessary for 222S and 325 buildings. I do not have a badge which provides for access to the 3000 area, although it appears necessary to be able to review PNL activities.

Please advise me of any additional training and applicable access control for security and safety.
