ORDER REDUCING AND ALLOWING CLAIM OF SPS TECHNOLOGIES, INC. (CLAIM NO. 753)

Fansteel Inc. ("Fansteel") and its affiliated debtors and debtors-in-possession (collectively, the "Debtors") having filed the Debtors' Fourth Omnibus Substantive Objection to Claims, dated December 2, 2003 (the "Objection"), seeking entry of an order pursuant to 11 U.S.C. §502(b) and Local Rule 3007-1 disallowing, reducing or reclassifying certain claims; and SPS Technologies, LLC, f/k/a SPS Technologies Inc. ("SPS") having filed its Response in opposition to the Objection [Docket # 1694] on January 6, 2004, and the hearing on the Objection to Claim No. 753 filed by SPS having been adjourned, on consent of the parties, to the next claims objection hearing date; and it appearing that the Debtors and SPS having reached a consensual resolution of the Objection as set forth in this agreed Order, it is hereby.

ORDERED, that Claim No. 753 filed by SPS shall be reduced from the amount of \$311,491.62 to the amount of \$309,128.77 and shall be allowed in such reduced amount as a Class ESC-3 general unsecured claim in the Escast, Inc. Chapter 11 case.
