Dear Mr. Harmon:

This is in reference to your letter dated January 26, 2004 requesting to amend Nuclear Regulatory Commission License No. 37-00030-08. In order to continue our review, we need the following additional information:

In your request, you did not provide Zacharia Laubach's training and experience. Please describe the individual's on-the-job or formal training, including the location and duration of the training. Training should cover (a) principles and practices of radiation protection, (b) radioactivity measurements, standardization, and monitoring techniques and instruments (c) mathematics and calculations basic to the use and measurement of radioactivity, and (d) biological effects of radiation. The description of the use of licensed materials should include the specific isotopes handled, the maximum quantities of materials handled, where the experience was gained, the duration of experience, and the type of use. The training this individual received should be commensurate with your proposed maximum possession limits and the activities authorized by this license.

In accordance with 10 CFR 2.790, a copy of this letter will be placed in the NRC Public Document Room and will be accessible from the NRC Web site at <http://www.nrc.gov/reading-rm.html>.
