SUBJECT: PALO DURO BASIN BOREHOLE GEOPHYSICAL LOGS

During the management meeting on June 18, 1985, you and your staff requested copies of borehole geophysical logs produced as part of our Palo Duro Basin study program. Attached are copies of all logs run in the Black #1 Well as part of a cooperative agreement between Stone and Webster Engineering Corp. (SWEC) and Pennzoil Company, owners of the well.

Logs of the Taylor Well were procured by SWEC from Petroleum Information Corp. (PI); DOE and its contractors had no involvement in the drilling and testing of this well.
