This letter is in response to your October 14, 1983 letter to me requesting various kinds of information from NRC (see Enclosure 1). We have responded below to all but your third and fourth requests, which will be answered in the new few weeks.

Updated Listing of Ongoing and Completed NRC and NRC Contractor Reports (Request 1 and 2)

A listing of selected NRC and NRC contractor reports, both released and in-process is near completion and will be sent directly to you next week. Copies will also be available for next week's Civilian Radioactive Waste Management Information Meeting. This listing is a selection of NRC guidance products and other staff and contractor reports which we believe closely reflect our positions and thoughts on various issues and concerns at this time. I will inform you of our plans for providing complete listings of our released and in-process reports in the next few weeks.

We are giving you a copy of the High-level Waste General File (Enclosure 2) which is in NRC's Public Document Room. As Donna Mattson discussed with you we are also attaching the Salt File (Enclosure 3) which will be sent to the PDR next week. This is the list that the Division of Waste Management sends to the PDR rather than the actual PDR list. Periodic updates of both lists will be given to you.
