The purpose of this modification is to (1) exercise Option Year Two to extend the period of performance of the contract from January 31, 2004, through January 31, 2005 and incorporate FAR clause 52.232.18 "AVAILABILITY OF FUNDS"; (2) increase the contract ceiling by \$174,621.90 from \$249,058.50 to \$423,680.40; (3) increase the amount funded in the contract by \$25,000, from \$234,000.00 to \$259,000.00; (4) Revise Section B of the Contract. Accordingly, the contract is hereby modified to read as follows:

1. Section B – CONTINUATION BLOCK, as stated in the contract, is hereby deleted in its entirety to incorporate the following:

(1) revise the Schedule of Items and Prices (Section B.3) to reflect the NRC's increased need for editorial services and decreased need for preprint manuscript review, as well as the increased need for electronic editing and the revised distribution of service level requests; (2) revise the Background and Objective (Sections B.4 and B.5) to reflect the recent reorganization within the Office of the Chief Information Officer; (3) revise the Types of Manuscripts (Section B.9) to reflect the variety of manuscripts that the Contractor may be asked to edit; (4) revise the Electronic Editing requirements (Section B.13); and (5) revise the discussion of Consideration and Obligation Delivery Orders (Section B.20) for consistency with the revised Schedule of Items and Prices in Section B.3. Accordingly, the contract is hereby modified to read as follows:

Substituted with the following in lieu thereof: "Section B – CONTINUATION BLOCK (JANUARY 31, 2003)" (See Attachment 1).

2. Refer to Section C – CONTRACT CLAUSES, add the following Clauses:

C.10 52.232.18 AVAILABILITY OF FUNDS (APR 1984)

"Funds are not presently available for this contract. The Government's obligation under this contract is contingent upon the availability of appropriated funds from which payment for Contract purposes can be made. No legal liability on the part of the Government for any Payment may arise until funds are made available to the Contracting Officer for this contract and until the Contractor receives notice of such availability, to be confirmed in writing by the Contracting Officer."

This modification obligates FY 2004 funds in the amount of \$25,000.00.
