## Web Redesign Working Group Meeting Minutes October 16, 2001

W. Oliu, OCIO, opened the meeting by describing the status of events affecting the public Web site in the aftermath of the terrorist attacks of September 11, 2001.

- The EDO required that the OCIO remove the external site from public availability for safeguards reviews on October 11. This decision applied to all the non-nrc.gov sites, as well, such as Rulemaking and the State and Tribal Program sites that are hosted at National Labs. These, too, will undergo review.
- In the meantime, the former public site was made available to the staff as a link on the agency's internal home page. Offices continue to update their document collections and other dynamic information on this site.
- The EDO also requested that the OCIO post a much-reduced public site on October 17
  and so inform the agency with a Network Announcement. The public site will
  incrementally grow in scope as the reviews are completed.

These developments will affect the redesign substantially. The OCIO plans to propose to the Web Redesign Steering Committee that the content, design, and navigability features of the public site be drawn from the redesign prototype.

The OCIO staff went on to discuss the status of the Training Plan, the approval of DreamWeaver as an authorized agency Web authoring tool, broken link fixes from the internal to the redesigned site, and the manner in which redirect pages will be implemented.

D. McGee, OCIO, requested that Working Group members send him the names of those in their organizations who will be attending the upcoming Web Training Course at the Professional Development Center. The course is scheduled for early to mid-November.
