The proposed license amendment would allow an 8 percent increase in the maximum authorized power level, from 3441 megawatts thermal (MWT) to 3716 MWT.

The purpose of this letter is to provide the results of the NRC staff's acceptance review of the EPU application for Waterford 3. The acceptance review determines whether or not there is sufficient detail to allow the staff to proceed with its detailed technical review. The review also ensures that the application adequately characterizes the regulatory requirements and licensing basis of the plant.
