2) Physical Description

This shipment consists of 48 x 48Y Cylinders loaded on 2 lash barges (24 & 24 cylinders per barge). RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U – 395,000 kgs.


