What I was trying to point out was that the Annual Assessment letters signed by the NRC Regional Branch personnel and sent to licensees on March 3, 2004 used 2.790. I'm merely suggesting that until IM 0305 is revised, that the NRC should use the correct citation to Section 2.390 in future correspondence with licensees.
