The following HQPs have been revised and will be officially adopted into the QA program as of February 14th, 2000. Copies of these procedures can be found on the N-drive. For those personnel who use these processes or procedures, please take the time to read the new procedures.

HQP 2.2: Execution of HQAM and Extension to a Fabricator's Facility (New Revision : 7): Essentially a format change except references to HQP 2.3 have been eliminated and the allowance for the fabricator to use its own nonconformance form rather than an SMDR was added.

HQP 7.0: Receipt Inspection (New Revision: 6): Essentially a format change. The MRF was added to this procedure since HQP 2.3 (its former residence) was eliminated.

HQP 7.4: Approved Vendor List (New Revision: 8): Modified to incorporate comments from Clients. The major change was to ITS category B suppliers. The procedure requires that an audit, surveillance or overcheck testing be performed in order to be on the AVL.

HQP 12.0: Calibration (New Revision: 4): Procedure was reformatted and reorganized to add clarifications. A table has been added to clearly specify calibration interval times. Calibration requirements for pressure gages has been clarified.

HQP 15.2: Nonconformances (New Revision: 1): Complete revision. SMDRs and NCRs are now on the network and must be input and processed by the Project Manager (except generic NCRs which will be processed by the QA Manager). Closure of SMDRs are now the responsibility of the Project Manager. The review process includes technical reviews and the completion of checklists.

The Holtec Quality Procedure Manual is now at revision 20.
