Examples noted were RT well cutting sample logs were not updated when samples were sent for analysis, Form TOP-004 was not updated as samples were moved from initial storage location or subsamples identified for ENFE or BTFR, no evidence of receipt of brake valve housing covers for BTFR (corrected during audit), rock sample #2 not where indicated.
