(Dominion and DNC) hereby confirms that a primary policy is provided by Nuclear Electric Insurance Limited (NEIL). NEIL also provides excess and blanket nuclear property insurance. The Company's total nuclear property insurance coverage is \$2,550.0 million for North Anna Power Station, \$2,550.0 million for Surry Power Station and \$2,750.0 million for Millstone Power Station.
