Dear Mr. Bunting:

At our last meeting the Yakima Indian Nation was promised access to computer codes and documentation. The Yakima Indian Nation requests the NRC provide copies of the following computer codes with available documentation in order to begin our independent performance assessment analysis of the proposed Hanford repository.

- 1) SWIFT - Request the version updated by Stewart Silling - not the version currently available through the National Technical Information Service (NTIS)

Please provide the last input deck to SWIFT used by Linda Lehman and Ellen Quinn in their analysis of the flow path on the Hanford Reservation.

- 2) STREAMLINE - Particle tracking code used to plot flow paths generated by SWIFT
- 3) LATIN HYPERCUBE - Statistical sampling code
- 4) STEP-WISE REGRESSION - Statistical code
- 5) HEALTH EFFECTS CODE - Developed by SNLA

These codes are currently operational on the Brookhaven or Sandia Laboratories Cyber Systems. We intend to run them on the U.C.C. Cyber System. The most convenient format would be an unlabelled nine-track magnetic tape. In order to have the tape(s) reconfigured for our system we will need to know the tape density, conversion code (ASCII is preferred), block

Please advise of any costs accrued in the transfer of the codes. Please mail the requested material to the following address:


