NOTICE OF ISSUANCE OF UTILIZATION FACILITY LICENSE AMENDMENT

Please take notice that the Atomic Energy Commission has issued Amendment No. 4, set forth below, to License No. R-36. The amendment authorizes the Curtiss-Wright Corporation to shut down the research reactor facility located at Quehanna, Pennsylvania for a period of one year and to maintain the facility on a stand-by basis during this period as requested in the Corporation's application for license amendment dated August 17, 1960. The Commission has found that shutdown of the reactor facility and maintenance on a stand-by basis in accordance with the procedures described in the licensee's application for amendment will not present any undue hazard to the health and safety of the public and will not be inimical to the common defense and security.

The Commission has found that prior public notice of proposed issuance of this amendment is not necessary in the public interest since the conduct of the proposed activities does not present any substantial changes in the hazards to the health and safety of the public from those presented by the previously approved operation of the reactor.
