SUBJECT: SUMMARY OF THE FEBRUARY 12, 2004, PUBLIC MEETING TO ALLOW THE LICENSEE TO STATE THE BASIS FOR REQUEST TO RESTART REACTOR OPERATIONS AT THE DAVIS-BESSE NUCLEAR POWER STATION

On February 12, 2004, the Nuclear Regulatory Commission (NRC) held a public meeting at the Camp Perry Clubhouse in Port Clinton, Ohio. The meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to allow the licensee to state the basis for their request to restart reactor operations at the Davis-Besse Nuclear Power Station.
