ICF Incorporated is in receipt of your letter dated February 6, 2004 regarding the subject matter. Please be advised that on August 28, 2000, Kaiser Group International, Inc., ICF Consulting companies, and the United States entered into a settlement agreement to resolve fifteen years of open cost issues that were never addressed under our prior owners (i.e., the aforementioned Kaiser Group International, Inc.). As part of the settlement agreement between the parties, ICF Consulting released and relinquished any and all rights to retainages and rate variances and to any and all costs, profits and fees accrued or otherwise owned in connection with services provided through December 31, 1999. Although the subject contract expired on January 2, 2000, no additional cost was incurred for the last two days of the contract.

We recognize the importance of administratively closing the contract. However, completing the Contractor's Release will require ICF to locate pertinent contract files and perform the financial analysis. This will mean unnecessary administrative cost and will only further delay the process. In lieu of the Release of Claims document you have requested to be completed, please consider this letter as an official notice that ICF Incorporated does remise, release, and discharge the Government its officers, agents, and employees, of and from all liabilities, obligations, claims, and demands whatsoever under or arising from the subject contract.
