Dear Dr. Patrick:

The subject task order expired on September 30, 1998, and we are initiating closeout action. However, pending completion of all closeout requirements, it is necessary to deobligate excess funds remaining under the task order for other immediate agency requirements. The purpose of modification no. 8 is to decrease the Task Order ceiling and obligated amount by \$314.12. Accordingly, the task order is modified as follows:

The first sentence, second paragraph of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 11 shall be in effect from January 27, 1997 through September 30, 1998 with a cost ceiling of \$54,826.80.
