This modification deletes Modification 12 in its entirety. The purpose of this modification is to deobligate funds in the amount of \$6,402.91 decreasing the obligated amount from \$590,252.00 to \$583,849.09. Accordingly, the contract is hereby modified as follows:

Under Section B.3, Consideration and Obligation-Cost Plus Fixed Fee, paragraph (c) is deleted in its entirety and replaced with the following:

"(c) The amount presently obligated with respect to this contract is \$583,849.09"

All other terms and conditions remain the same.
