SUBJECT: CURTISS-WRIGHT CORPORATION - REQUEST FOR OPERATION AT FULL POWER

Curtiss-Wright Corporation built a 1 Megawatt Research Reactor in Quehanna, Penna. Pending the installation and completion of the cooling system, operation of the reactor was limited to a maximum of 100 Kw. Curtiss-Wright Corporation now informs us that the primary coolant system is completed and fully instrumented. The heat exchanger, cooling tower and secondary coolant system pumps are not yet installed. The licensee requests permission to make short runs up to the design power of 1 megawatt in order to test the cooling system and the shielding. Operation at 1 megawatt is feasible because the reactor pool water contains approximately 147,000 gallons of water at room temperature. Assuming no external cooling source it is estimated that reactor operation at a power of 1 megawatt for a period of 10 hours would result in heating the reactor pool water from about 64°F to 100°F.

The licensee requests permission to operate the reactor at 1 megawatt power under the following conditions and restrictions:

primary coolant flow rate 700 gallons per minute slow shutdown-low flow 525 gallons per minute (75% of normal rated flow) differential temperature across the core 10°F alarm temperature - core effluent 110°F

Calculations submitted by the licensee indicate that operation under the above stipulated conditions would result in an average maximum fuel temperature of about 114°F. The calculations were based on a core array of 4 x 5, no reflector elements in the core.

The analysis of the reactor design and the supplementary information presented in the request for the amendment indicated that the reactor can be operated under the conditions and restrictions stipulated above without undue hazard to the public.

The analysis of the reactor design and the supplementary information presented in the request for the amendment indicated that the reactor can be operated under the conditions and restrictions stipulated above without undue hazard to the public.
