

The purpose of this modification is to:

1. Provide incremental funding in the amount of \$413,000.00, thereby increasing the obligated amount of this contract from \$531,000.00 to \$944,000.00;

Accordingly, this contract is modified as follows:

1. Section **B.24 CONSIDERATION AND OBLIGATION** is hereby **DELETED** in its entirety and **REPLACED** with the following in lieu thereof:

"B.24 CONSIDERATION AND OBLIGATION

- (a) The total estimated cost to the Government for full performance under this contract is \$2,103,512.00.
- (b) The amount presently obligated by the Government with respect to this contract is \$944,000.00.
- (c) It is estimated that the amount currently allotted will cover performance through December 31, 2004."

All other terms and conditions remain the same.

This modification obligates FY2004 funds in the amount of \$413,000.00.
