


Region II Organization



NRC Performance Goals

- Maintain safety and protect the environment
- Enhance public confidence
- Improve effectiveness, efficiency, and realism of processes and decision making
- Reduce unnecessary regulatory burden

Reactor Oversight Process



Examples of Baseline Inspections

• Equipment Alignment ~92 hrs/yr

Triennial Fire Protection
 ~200 hrs every 3 yrs

Operator Response ~125 hrs/yr

• Emergency Preparedness ~80 hrs/yr

• Rad Release Controls ~100 hrs every 2 yrs

Worker Radiation Protection ~100 hrs/yr

Corrective Action Program ~200 hrs every 2 yrs

• Corrective Action Case Reviews ~60 hrs/yr

Significance Threshold

Performance Indicators

Green: Only Baseline Inspection

White: May increase NRC oversight

Yellow: Requires more NRC oversight

Red: Requires more NRC oversight

Inspection Findings

Green: Very Low safety issue

White: Low to moderate safety issue

Yellow: Substantial safety issue

Red: High safety issue

Turkey Point Nuclear Plant Inspection Activities

(Jan 1 - Dec 31, 2003)

- 3654 hours of inspection related activities
- Engineering inspections
- Emergency preparedness inspection
- Licensed operator exam inspection
- Radiation protection inspections
- Reactor pressure vessel head and head penetration nozzles inspections
- Reactor pressure vessel lower head inspection
- Units 3 and 4 refueling outages

Turkey Point Nuclear Plant Assessment Results

(Jan 1 - Dec 31, 2003)

- Plant performance was within the Licensee Response Column of the NRC's Action Matrix
- All inspection findings were classified as very low safety significance (Green)
- All PIs were Green

Turkey Point Nuclear Plant Annual Assessment Summary

January 1- December 31, 2003

- Florida Power and Light Company operated Turkey Point Nuclear Plant in a manner that preserved public health and safety
- All cornerstone objectives were met
- NRC plans baseline inspections at Turkey Point Nuclear Plant for the remainder of the assessment period

- Radiation protection inspection
- Reactor head replacement inspection
- Unit 3 refueling outage with head replacement
