CONSENT TO CONFIRMATORY ORDER MODIFYING LICENSE
THERMO-LAG 330-1 CORRECTIVE ACTIONS

In a December 18, 1997 letter, Virginia Electric and Power Company committed to take corrective actions with regard to Thermo-Lag 330-1 radiant energy shields for Surry and North Anna. In a May 14, 1998 letter, the staff requested Virginia Electric and Power Company's consent to modify the licenses for Surry and North Anna by order to make these commitments a requirement. This letter provides our consent to the issuance of a Confirmatory Order Modifying License and the waiver of our right to a hearing on any or all of the Order. Attachments 1 and 2 provide a signed statement that Virginia Electric and Power Company intends to complete the committed corrective actions for installed Thermo-Lag 330-1 radiant energy shields at Surry and North Anna Power Stations, respectively.

The identified corrective actions for North Anna Unit 2 were completed during the recent refueling outage that ended on May 1, 1998. Therefore, we request modification of the proposed North Anna Confirmatory Order Modifying License to only address completion of the Unit 1 corrective actions.



I, James P. O'Hanlon, Senior Vice President-Nuclear, Virginia Electric and Power Company (VEPCO), Surry Units 1 and 2, hereby agree on behalf of VEPCO that VEPCO will comply with the following commitment:

VEPCO shall complete final implementation of Thermo-Lag 330-1 radiant energy shields corrective actions at Surry Units 1 and 2, described in the VEPCO submittal to the NRC dated December 18, 1997, by the completion of the next refueling outage scheduled to begin in October 1998 for Unit 1, and scheduled to begin in April 1999 for Unit 2.


